## PRESIDENT'S REPORT

- 1. Dr. Speert welcomed Dr. Darryl Greer, Executive Director of the New Jersey Association of State Colleges and Universities. Dr. Greer has been representing the interests of NJ colleges and universities since 1986, and has been at the forefront of shaping the needs of higher education in New Jersey. Dr. Greer lauded the University and the President for the many accomplishments over the last 15 years. He reported on the **College Bound 2008 project**, which has included business executives and public opinion polling, focus groups, policy research, and reports by national experts. A special College Bound 2008 state-wide conference on the future challenges of higher education in NJ, especially the growing demand for quality public college access, is scheduled for March 28. The 2008 refers to the year NJ high school graduates are expected to reach a peak number of 100,000.
- 2. Dr. Speert introduced and congratulated the faculty members who were reappointed with tenure at the December 2000 Board meeting. They were thanked for attending the meeting and providing the trustees an opportunity to meet each of them at the luncheon today.
- 3. Coach Jose Rebimbas and the Pioneer Basketball Team's strong performances have led them to finishing first in the NJAC and once again qualified for the NCAA Division 3 regional playoffs. Star player, Horace Jenkins was feaured in <u>Sports Illustrated Magazine</u> and is close to setting an all time WP record for points scored. The team is rated 11th in the nation.
- 4. The State Boards of Education from Paterson, Newark and Jersey City are meeting at WP today. College of Education Dean, Leslie Agard-Jones, is participating as an interim member of the Paterson Board.
- 5. This year's Legacy Award Dinner will be held on Saturday, May 12 and will be honoring State Farm Insurance, John Soldoveri, Greater Community Bancorp Chair, and Cora Ann Mahalik, Class of '76 alum and channel 9 TV anchor. The proceeds will be used for scholarships.

## MINORITY AFFAIRS COMMITTEE

Henry Pruitt, Chair, noted that WP is a leader among higher education institutions in its efforts and progress on diversity. Plans are under way for a Minority Vendor Fair to be held on campus on March 20,2001. Minority and women owned businesses (MBE/WBE), and New Jersey colleges and universities will receive invitations. Thanks were expressed to Sydney Barksdale, Associate VP for Diversity and Minority Affairs for arranging the Provost's Diversity lecture which was presented yesterday. The noted speaker was Manning Marable, Professor of History and Political Science and the Founding Director of the Institute for Research in African-American Studies at Columbia University.

## FINANCE AND AUDIT COMMITTEE

Robert Taylor, Chair, reported that the committee had met and discussed the resolutions for approval today. The Equipment Leasing Fund resolution was approved by a Board Conference Call meeting on Wednesday, February 21, 2001. Student enrollment figures for Fall 2000 and Spring 2001 averaged 9710 for the year; over 7053 FTE's were reported for the fall, the highest since 1983. Dr. Speert added that advertising promotions have been well received and noted that applications are up 12%. The revenue/expenditure balance for FY2001 currently represents a \$1 million shortfall; plans to cut expenses are in place. The committee reviewed the Internal Auditor's Report.

WHEREAS:

The principle of shared governance is central to American higher

education and effective governance enhances the University's

capacity to fulfill its mission, and

WHEREAS:

The administration and faculty leadership have worked collaboratively to develop the attached governance statement which provides a common understanding of the roles and responsibilities of the students, faculty, staff, administration and Board of Trustees in the

governance of William Paterson University; therefore, be it

RESOLVED:

That the University adopts the attached "University Governance

Statement" for William Paterson University.

## William Paterson University University Governance Statement

### Introduction

This statement is a call to mutual understanding among the Board of Trustees, administration, faculty, and students (operating within the laws and agreements of the legislative and executive agencies of the State of New Jersey and the collective bargaining units) regarding their roles and responsibilities in the governance of William Paterson University. It is recognized that the participation of these constituent bodies in University governance is an integral part of the institution's decision-making process. Therefore, the cooperative and collaborative resolution of problems and addressing of issues is a shared value for all members of the community. There is mutual responsibility to assure that in all institutional matters and deliberations, regard for the welfare of the University is of the utmost importance. Each constituent group supports and affirms the roles and responsibilities of the others in University governance.

## Roles and Responsibilities

The governance of William Paterson University is vested in the Board of Trustees pursuant to statute 18A:64-2-6 of the State of New Jersey. The Board of Trustees is the final institutional authority overseeing the affairs of the University. While maintaining a general overview, the Board entrusts the management, administration, and conduct of William Paterson University to the President and his/her designees. In consultation with and/or upon the recommendation of the President, as necessary, the Board adopts policies in support of the mission of the University and provides general direction on matters including but not limited to planning, curriculum, instruction, research/scholarship and service, funding and budgeting, student development, enrollment management, human and physical resources, and institutional advancement. The Board appoints the President through a process that can include participation by faculty, staff, students and other appropriate constituents. In developing, adopting or amending its bylaws, the Board may consult the President, faculty and staff. The Board takes all appropriate actions to assure and protect the integrity of the University and its mission.

The President is the Chief Executive Officer of the University and has responsibility for the operation and general management of the University as defined by acts of the state legislature (NJSA 18A:64-2-6) and the bylaws of the William Paterson University Board of Trustees. He/she is responsible directly to the Board. The President shall exercise all the powers requisite for the overall leadership and administration of the University, and shall develop, execute and enforce the policies, rules and regulations relating to that responsibility through his/her designees. The President, with the approval of the Board of Trustees, appoints members of his/her administrative team including the Provost, Vice Presidents, Deans and others with the advice and consultation of the appropriate faculty, staff and students. He/she represents the University to the public, and with his/her designee, presents the views of faculty, staff and students, when and if appropriate, to the Board, and transmits the Board's response and views directly back to the faculty, staff and students.

The faculty is responsible for developing and making recommendations regarding academic and curricular matters, policies and requirements. This includes but is not limited to instruction, research, scholarship, creative activity, service, course content/subject matter, student advisement, classroom standards, grading standards, assessment, course assignments and schedules, degree requirements and initiation of academic programs, continuing education and distance learning offerings, standards for academic freedom and procedures and/or agencies for handling conditions of employment. Action on some of these responsibilities (i.e., curriculum, academic standards, standards for academic freedom and assessment) is more properly recommended to the President or his/her designee through the Faculty Senate. Faculty and staff should also be accorded the opportunity to participate in formulating policies on such issues as

admissions standards, standards for student conduct and discipline, planning, marketing, resource allocation, the structure of the various academic units, and other items as negotiated with the appropriate collective bargaining unit. The faculty of each department elect their chairperson at a department meeting, or as specified in the department's bylaws and established University policy subject to approval and appointment by the President. The faculty elect their department committees and recommend course assignments and schedules through their chairperson and dean of their respective college. The faculty recommend to the administration on the perquisites of faculty status, including tenure, the allocation of faculty positions, appointment, retention, and promotion of colleagues in their department.

The Faculty Senate is the elected representative body of the faculty, librarians and professional staff, and acts in an advisory capacity to the University administration on matters of campus-wide concern to faculty. The Senate will have discussions and input, both from committees and the Senate forum, that will provide a mechanism to foster the goals, objectives, policies, and procedures of the University community. The Senate has the authority to appoint its own standing and ad-hoc committees in accordance with its bylaws. Matters pertaining to collective bargaining are the responsibility of the bargaining units, and are not within the purview of the Senate.

The respect of William Paterson students for the University will be enhanced if they are given at least these opportunities: (1) to be heard in the classroom without fear of institutional or faculty reprisal for the substance of their views; (2) to be free to discuss questions of institutional policy or operation within the formal governance bodies of the institution, i.e. representation on the Board of Trustees, Faculty Senate, and other campus committees; (3) to have access to due process when charged with violations of University regulations; (4) to have the same right to hear speakers of their own choice based on the principles of the University's mission as is enjoyed by other constituencies of the institution.

The Student Government Association (SGA) is the elected representative body of the students and serves in an advisory capacity to both the University administration and faculty. Students of William Paterson University are encouraged to participate responsibly in the governance of the University. Their participation should be recognized as a claim to opportunity both for educational experience and for involvement in the affairs of their University. Ways should be maintained, explored and expanded whenever possible to permit significant participation by students. If institutional support is to have its fullest meaning it should incorporate the strength, vitality, and idealism of the University student body.

Generally, all constituent groups as defined in this statement affirm their commitment to work and cooperate with one another for the fulfillment of the University's mission, including long range planning. The Administration, colleges, departments and the Faculty Senate have the right to appoint committees to perform various tasks. Efforts should be made, if and when appropriate, to ensure that appointed and/or advisory committees are inclusive and representative of the University community, and that they are complementary to rather than duplicative of one another. Care should be taken to preserve the rights of individuals.

The faculty, staff, and students expect to make recommendations before final action is taken on the matters herein, but acknowledge that these recommendations are subject to the final decisions of the President and/or Board of Trustees.

## Guidelines for Compensation for Department Chairpersons for the Summer 2001

Appendix 12 Minutes of the April 28, 2001 Board Meeting

Compensation for Department Chairpersons for Summer 2001 shall be based on the following guidelines:

- A. For responsibilities in conjunction with the August registration period, I credit hour will be granted for each department chairperson;
- B. For responsibilities in conjunction with Summer Session I and Summer Session II, 1.5 credit hours will be granted to each department for each session.
- C. Additional credits will be awarded for each summer session dependent upon the number of sections offered:

3 or fewer = 0 credits 4 -11 = 1 credit 12-21 = 2 credits 22-32 = 3 credits 33-42 = 4 credits

D. Additional credits will be awarded based upon the number of FTE Faculty (determined by the previous Fall):

0 -15 = 0 credits 16-21 = 1 credit 22 or more = 2 credits

E. For any department in which the advisees in the undergraduate major number more than 250, I additional credit hour will be awarded for each additional 250 students or part thereof an additional credit will be given.

000-250 = 0 credits 251-500 = 1 credit 501-750 = 2 credits 751-1000 = 3 credits

F. For summer work, no Department Chairperson may receive less than the minimum compensation of 4 credit hours.

Among the numerous summer responsibilities of the Chairperson, the following are included:

- 1. Supervision of the department during the Summer Session;
- 2. Registration during August, not more than four days, and resulting schedule decisions during the following week;
- 3. Recruitment planning for 2001-2002;
- 4. Advisement of students;
- 5. Budget planning for the next year;
- 6. Service on College's student dismissal and probation appeals committees;
- 7. Facilities management;
- 8. Availability for participation in new student orientation activities in July for the equivalent of one working day.
- 9. Assignment of adjunct faculty;
- 10. Orientation of new full-time and adjunct faculty; and,
- 11. Revision of faculty schedules, based on final registration figures.
