**Faculty Application** 

<u>Purpose:</u> Open-access publishing promotes dissemination of intellectual work and can help to facilitate publication of WPU faculty research, scholarship, and creative expression. In recognition of these benefits and their alignment with WPU's mission, the Office of the Provost through the Cheng Library is making available funds to support open-access publication by WPU faculty authors.

<u>Eligibility:</u> Full-time faculty from any discipline may request funds for open-access publication fees. Funding is limited to \$800 per faculty per fiscal year. Exceptions may be made under extraordinary circumstances. Awards will be granted only with demonstrated validity of the open-access publication venue. Help with assessing the validity of open-access publishers can be obtained through the Cheng Library (<u>http://guides.wpunj.edu/openaccess</u> or contact Richard Kearney at kearneyr@wpunj.edu).

<u>Requests must be submitted upon acceptance of the work for publication.</u> Applicants are encouraged to request from publishers any available waivers before submitting application. Applicants will receive institutional cooperation to address waiver requests. Applicants with other support for open-access publication (e.g. funds budgeted for the purpose from a research grant) are expected to exhaust other funds before applying for funds through this program. <u>Deadline for applications in a given fiscal year will be May 15</u>. Awards will be made on a first-come basis while fund balances for the fiscal year remain.

Please note that all fees will be paid directly to the publisher; there will be no direct reimbursement to faculty authors.
