Standing Charges:

2019-20 Governance Council Summary of Activities

The Governance Council made great strides this academic year in fulfilling its standing and priority charges. The council reviewed priority charge #1 by assessing the new procedures outlined in the faculty handbook. The council advised that duplicating the procedures in the Bylaws would not be necessary but suggested the process could be formalized with the

development of an Executive Committee Manual [Priority Charge #3]. See Governance Response to Priority Charge #1

The council continued to review the Senate Council Standing Charges and the Senate Bylaws to ensure alignment (Priority Charge #2, Standing Charge #5). The Council began contacting identified councils and will continue to conduct outreach and collaborate to submit bylaw revisions, as necessary.

The Council assisted the Research & Scholarship Council in the development and proposal of a bylaw amendment changing the name of the council. The new Research, Scholarship, & Creative Expression Council was recognized with the adoption of the amendment on February 25, 2020. See Bylaw Amendment

The Council fulfilled Standing Charge #5 by updating the Senate Governing Documents and providing updated copies to the Senate Chair.

The Council became aware of growing concerns and interest in Senate Representation considering the University's discussion of academic reorganization. The Council began to research the impact of reorganization on the Senate and subsequently began a review of existing representative models at peer institutions. The Council was well prepared when the Senate Chair requested a review and possible short-term recommendation for the Senate to consider after academic reorganization decisions were announced. The Council submitted a short-term recommendation document to the Senate on March 18, 2020. See Recommendation

The Council is prepared to continuing research on various models of representation should the Senate submit a request to do so in the Council's Priority Charges for AY 2020-21.

Recommended Charges for The Next Academic Year: Standing Charges should remain unchanged.

Recommended Priority Charges 2020-21

- 1. Draft emergency and remote operational provisions for the Constitution and Bylaws.
- 2. Review and research various models of Faculty Senate representation.
- **3.** Continue to communicate with various Senate Councils where conflicts were noted in the Governance Council alignment review. Collaborate with the councils to propose necessary or recommended amendments or corrections.

Recommendations & Comments on Senate Representation in Response to Academic Reorganization

On March 10, 2020 the Faculty Senate referred concerns on the future of senate representation to the Governance Council. This referral is driven by the recently adopted Academic Reorganization.

Realizing this topic was of major concern when first mentioned in the Senate in the Fall of 2019, the Governance Council proactively began a review of the impact academic reorganization would have on the Senate body. The council wishes to work with the Senate and any interested parties to ensure the Senate embodies the *Fair and Just Representation* outlined in the Senate Constitution.

The chair of the Faculty Senate suggested members of the Senate submit questions and/or comments on matters related to academic reorganization and senate representation to the Governance Council. The Council has not received any communication from members of the Senate but we welcome questions, concerns, and suggestions as we continue our inquiry.

I.Immediate Impact

- 1. The following encapsulates our review of the immediate impact of Academic Reorganization and likely results should no action be taken by the Senate at this time.
 - a. Current voting membership of Senate N=45 (includes At-Large, PS, Lib, AF)
 - b. After reorganization voting membership N=39 (includes At-Large, PS, Lib, AF)
 - c. Impact by college

- 2. Based on the Constitution and the Academic Reorganization, the Elections Council would need to hold elections for the following Senate Representatives (in addition to regularly scheduled elections):
 - A. Professional Sales/Marketing & Management
 - B. Secondary & Middle School Ed/Elementary & Early Childhood Ed
 - C. Anthropology/Women's & Gender Studies/Africana-World Studies
 - D. Political Science/Geography & Urban Sciences
 - E. Languages & Cultures/Asian Studies (Program)¹
 - F. Mathematics/Physics
- 3. These elections would need to take place regardless of the Term of any current Senator from any department listed.
- 4. With no action taken by the senate the new representation would take effect immediately for the Senate term AY 2020-21.

II. Short Term Recommendation

The Governance Council *presumes* implementation of Academic Reorganization would take effect July 1st of FY 2020-21. To provide impacted departments, the Elections Council, and the Senate adequate time to properly adjust to academic reorganization the Governance Council is recommending a 1-year implementation of Academic Reorganization. To be implemented as follows:

- 1. The structure of Senate representation remains the same in AY 2020-21 as is currently in place.
- 2. Terms of impacted department representatives: There are 12 representatives impacted by reorganization. Under our recommendation only the following departments are immediately impacted due to their Terms ending in AY 2020:
 - a. Elem/Early Childhood Education
 - b. Physics
 - c. Languages & Cultures (see footnote 1)
 - d. Women's & Gender Studies
 - e. Geography & Urban Science
- 3. 1-year plan: To address the term issues of impacted departments we suggest the Senate implement a 1-year AY 2020-21 term for a Senate representative from each department (II.2 a-e). The remaining impacted department reps should fulfill their current 2-year terms scheduled to end in AY 2020-21.
- 4. Voting Threshold: To approve this 1-year implementation proposal we suggest a two-thirds majority vote of the Senate be established as the approval threshold. This threshold is suggested as it is the standard for Constitutional amendments. We do not suggest a Constitutional Amendment is necessary at this time. The recommendation is to implement a change in Senate Representation based on a change in University structure taking effect during the first Senate election cycle after reorganization is complete. A two-thirds majority reflects the importance of the issue and the acknowledgment that this is ultimately a Constitutional question. It should be understood that any long-term change to Senate Representation requires a Constitutional Amendment.

III. Rationale

- 1. Impacted departments should be afforded time to adopt new bylaws and engage in discussions surrounding future Senate Representation. A 1-year implementation would provide the necessary time to accomplish this.
- 2. The 1-year implementation would permit Senators elected to 2-year terms to complete their elected terms.
- 3. The 1-year implementation would place each of the impacted departments on a common election cycle.
- 4. The 1-year implementation permits the Senate to engage in a more in-depth discourse about Fair and Just Representation and consider any changes to the Senate Constitution in AY 20-21.
- 5. We feel this recommendation embodies the ideals of Fair & Just Representation as the Senate transitions.

IV. Additional Comments

- 1. We do not endorse or recommend any extension beyond 1-year. We believe any effort to do so would require a Constitutional Amendment.
- 2. A 1-year implementation does not convey any recommendation from the Governance Council for a change in the current Senate Representation structure. The Governance Council will fulfill its charge to the Senate by providing data and information to equip the voting membership with the tools to make any decisions related to Senate Representation. The Governance Council is available to provide guidance on any Constitutional questions and to aid departments in by-law revisions if desired (Standing Charge #3).
- 3. If the Senate wishes to charge the Governance Council with *recommending* other structures of Senate Representation, we would like the Senate to provide guiding principles to direct our inquiry. Responses and comments to the following can help forge these guiding principles.
 - a. How do Senators interpret and define "Fair and Just representation"?
 - b. Comments on the perceived size of the Senate in order to be a representative, effective, and efficient recommending body.
 - c. Comments on Diversity & Inclusion in Senate Representation.
 - d. Other thoughts, comments, questions, concerns?
