### **Accomplishments and Summary of Activities**

### **Programs Reviewed**

The Council members reviewed ten graduate programs. Among the noteworthy programs was the new graduate program developed by the Cotsakos College of Business in applied business

analytics. This new concentration is expected to attract more students and the course offerings will be offered predominately (75%) online to accommodate the scheduled of working students.

A second noteworthy program is the addition of the concentration in school nursing to the courses offered jointly by the departments of Nursing and Curriculum and Learning. This new concentration will allow students to earn a Master's degree after completing required courses in the Department of Nursing and adding nine credits of courses from the Department of Curriculum and Learning. The Dept. of English developed a combined BA/MFA program which is also exceptional for designing a unique undergraduate-graduate program for highly-motivated students.

The changes to the graduate degrees awarded by the departments of Kinesiology and Political Science are noteworthy for the attention of these departments in revising the programs to respond to current student demand. The revised M.A. in Public Policy will focus specifically on critical policy analysis, and the M. S. in Exercise and Sports Studies will add a concentration for Sport Administration which will build on the successful undergraduate major of Sport Management.

These changes reflect one of the themes reported by Provost Sandmann from the Academic Affairs Leadership Forum held early in the spring semester. One of the topics addressed at the forum was "Curricular development and redesign to meet evolving student and societal needs."
