

MINUTES
**MEETING OF THE BOARD OF TRUSTEES OF
THE WILLIAM PATERSON UNIVERSITY OF
NEW JERSEY**

Friday, September 20, 2024

The meeting was called to order at 9:01 a.m. in the 1800 Valley Road Board Room. Trustees were both in attendance and participating via a virtual platform.

ANNOUNCEMENT CONCERNING ADEQUATE NOTICE OF MEETING:

In accordance with the "Open Public Meetings Act," the Chairperson publicly announced and had entered into the minutes that adequate notice of this meeting was provided. In compliance with the Statute, this notice was posted in advance on the University's web page and distributed to The Herald News, The Record, and The Star Ledger more than 48 hours prior to this meeting.

It was moved and seconded to adopt the following resolution:
RESOLUTION 9-24-1, TO MOVE INTO EXECUTIVE SESSION
The resolution was unanimously adopted.

At approximately 10:45 a.m., the Public Session resumed.

Chair Michael Seeve welcomed everyone to the in-person and virtual meeting. He thanked members of the University community who have participated in the governance of the University by attending the Board meeting and reported that the Board did not have a request for public comment. Mr. Seeve then read the University's Land Acknowledgment statement.

Trustee Kevin Lenahan made a motion to amend the agenda to include a Resolution that was inadvertently left off the FAID committee agenda. The resolution, marked Resolution 9-24-8, involves a naming opportunity resulting from a gift donation to the University. The Chief of Staff sent the resolution to the full board for review prior to today's meeting.

It was moved and seconded to amend the meeting agenda to add Resolution 9-24-8, Naming of the Reading Clinic in the College of Education at William Paterson University.

APPROVAL OF MINUTES JUNE 20, 2024, BOARD OF TRUSTEES MEETING:

The minutes of the June 20, 2024, Board Meeting were approved as distributed.

CHAIR OF THE BOARD OF TRUSTEES REPORT

Chair Michael Seeve stated that the Board Committees met on September 5th, stating that at the Committee meetings, issues are thoroughly discussed and vetted, then are moved forward to the agenda for the full Board meeting. The Vice Presidents and others in the University community updated the trustees on various items. Mr. Seeve further stated that at the September meetings, the Finance, Audit, and Institutional Development Committee met with Chief Financial Officer Loewrigkeit and Chief Information Officer Bartle. The committee then heard reports from several Vice Presidents, including reports on the fiscal health of the University from CFO Loewrigkeit, reviewed bid waivers, and heard reports from Cabinet members on Enrollment and Retention and Institutional Advancement. He also stated that the Educational Policy and Student Development Committee heard two presentations – one on graduation rates and another on certificate programs. Other topics related to personnel were discussed by the Personnel Committee and are confidential. Mr. Seeve noted that we will have an opportunity to recognize new Emeriti faculty at today's meeting. Dr. Helldobler has let the Board know of the positive feedback he has received from faculty, staff and especially students now that they are back on campus for the fall semester. The Board continues to monitor enrollments and the budget as planning continues for the University's future.

Mr. Seeve welcomed a new Student Trustee, Xavier Clavijo. He announced that Mr. Clavijo will be the non-voting Student Representative on the Board of Trustees for the academic year 2024-2025. Xavier is an Honors College student majoring in financial planning with a minor in professional sales. Xavier is a student ambassador for the Russ Berrie Institute for Professional Sales within the Cotsakos College of Business, as well as Vice President of the Professional Sales Club. He is an Excel Honors and Purple Thread Sunrise Scholar and is a student mentee of the Pesce Family Mentoring Institute. Xavier has also been featured in multiple marketing campaigns at William Paterson University. Previously, he served in the Student Government Association as an at-large member and senator of the allocations committee. Xavier Clavijo was then sworn in by General Counsel Melissa Reardon Henry, joined by President Helldobler and Vice President Cammarata. Mr. Seeve congratulated Xavier and stated that the trustees are happy to have him at the board table and look forward to his service.

PRESIDENT'S REPORT

President Helldobler thanked Mr. Seeve for his report. The President noted that his full report, with recent accomplishments of the faculty, staff, and students since the last Board meeting, is included in the meeting materials. Below are a few highlights Dr. Helldobler mentioned in his

report.

Dr. Helldobler stated this is the second year the University has opened the semester with a Welcome Day celebration for our first-year students. Faculty, staff, and administrators wore “What Will You Power?” orange Pio t-shirts and cheered the students in the Shea Center, where they heard from several speakers, including two of our Trustees. The President thanked Trustee Audrey McDowell and Student Trustee Jason Peralta for being available at this special event and noted the positive tone that was set for the new students to see so many supportive faces on stage. He also mentioned the great shower of confetti at the Welcome Day convocation. Dr. Helldobler stated that the students spent the remaining time engaged in various activities to help them get acclimated to campus.

Dr. Helldobler stated that for the fourth year, the Aspiring Educators summer program brought 58 area high school students to campus as part of an effort to expand and diversify the state’s teaching workforce. He also stated that according to the New Jersey Department of Education, while approximately 61 percent of children in New Jersey’s public schools come from racially and ethnically diverse backgrounds, approximately 81 percent of teachers in the state are White. Our partnership with regional high schools serving diverse school communities brings rising juniors and seniors who are interested in teaching as a profession to campus. They take a university course on teacher education, earning three college credits, and the tuition is covered through contributions from the partner school districts and grant monies. High school students spend time working on campus as teaching assistants in the University’s Summer Youth Program, earn a \$2,000 stipend, and have valuable résumé-building experience.

Dr. Helldobler also informed us that this summer in August, we welcomed New Jersey Lieutenant Governor **Tahesha Way** to campus as part of a women’s equity conference we hosted, where she praised William Paterson University’s Small Business Development Center (SBDC) to an audience of nearly 200 established and aspiring women from across northern New Jersey. This year alone, New Jersey’s SBDC at William Paterson University served 700 businesses, 356 of which are women-owned.

Dr. Helldobler reported that NJBIZ has selected William Paterson University Board of Trustees member Will Pesce, the retired President and CEO of John Wiley & Sons, as a 2024 NJBIZ ICON Honoree. The ICON Awards honor New Jersey business leaders for their notable success and strong leadership within and beyond their chosen field, resulting in outstanding contributions to their industry and community. Mr. Pesce was among 37 individuals from across the state who were recognized. A 1973 graduate of WP and a member of our board since 2002, Will is a tremendous supporter of William Paterson. He and his family established the Pesce Family Mentoring Institute in 2014. The Institute will celebrate its ten-year anniversary this fall.

Dr. Helldobler congratulated Dr. David Fuentes, associate dean of the College of Education, who received a 15-month, \$564,000 grant from the New Jersey Department of Labor to support the initiative *Growing Apprenticeships in Nontraditional Sections – 2024*.

The baseball locker room in the athletics fieldhouse will be named in honor of the late Alan J. Anderson, class of 1981, and a member of the William Paterson University Athletic Hall of Fame, in recognition of a \$200,000 donation from the Alan J. Anderson Foundation to the Pioneering Champions Campaign. The campaign seeks to raise \$1.5 million in support of an addition and renovation of the athletics fieldhouse, an initiative designed to provide the institution's student-athletes with the resources they need to compete and succeed at the highest level.

The Pioneer baseball, women's basketball, volleyball, and men's and women's swimming and diving programs all earned team academic awards from their respective national coaches' organizations.

Lastly, he also stated that a new fleet of eco-friendly shuttles has hit our campus roads as part of our ongoing and award-winning commitment to environmental sustainability. The vehicles' exteriors have been wrapped with fun, WP-spirited graphics that feature mascot Pio "waving" from a window, plenty of Pioneer orange, and our Will. Power. motto. The new shuttles are 100 percent electric with zero carbon emissions, and they boast the latest technology and whisper-quiet rides, which are great for the environment and passengers' safety and comfort.

Dr. Helldobler mentioned that the University hosted the New Jersey Ballot Bowl, a friendly competition between universities to encourage voter registration and voter turnout. Lt. Governor Way delivered remarks as did two New York Giants football players. The university mascots were also in attendance. The President thanked Trustee Idida Rodriguez, who delivered remarks and supported our students.

Trustees congratulated Mr. Pesce for his recognition.

This concluded Dr. Helldobler's report, and he encouraged everyone to read his full report.

FALL 2024 ENROLLMENT AND RETENTION REPORT

Vice President for Enrollment Management, George Kacenga, provided a Fall enrollment outlook and retention update.

Dr. Kacenga reviewed the Fall 2024 Enrollment-Census I / Projected Final slide of his presentation and noted that Census I was on 9/13/24. He reported that for the university headcount for Census Fall 2023, we were at 9428, and for Census I, we are trending up significantly at 9941. The University is currently at 6649, which is tracking above where we were at Census I last year for undergraduate headcount. The graduate headcount is 3292. Last year and at this time, we were at 2876, which is also trending up. For the main campus, he noted as a reminder that we end up counting the head count for dual enrollment and how they go into the headcount, but it does not impact net tuition in the same way. For WP Online, last year, we were at 3442, and we are currently at 3992, trending up. Dr. Kacenga also discussed how the University is doing well in the non-returning student area. He highlighted the incredible work happening right now within the Enrollment division. He commended Steve

Quinn for his leadership and all his work with that team to recruit. He also recognized Stacy-Ann Brown in financial aid, Johanna Torres in student enrollment services, and Susan Astarita as the Registrar.

Vice President for Student Development, Miki Cammarata presented a report on retention on different demographics. She noted that not a lot has changed since the committee meetings and that we are above the goal by 1.2%. She reviewed the cohort comparison slide, which showed mostly growth. Mrs. Cammarata reviewed the slide with the gender and race cohorts, which also showed great gains, especially where we have dedicated ourselves and are in our strategic plan. She noted the big gains in Hispanic and Black student populations. Her third slide was divided by college, and she noted that most students are not actively engaged with their particular college in their 1st year. She stated that they do recognize that much of the advisement and support that the students are receiving in their 1st year is from the professional advisors, financial aid, and the navigate success team. She stated that this is a partnership between us and the colleges. This concluded her report.

Dr. Kacenga then presented the positives and negatives regarding the enrollment drivers that they know through Census I. He pointed out that one of the negatives they are paying close attention to is WPOne new transfers are behind Fall 2023. Regarding positive drivers, the university has the highest overall enrollment as of 9/13/24 since 2020.

Dr. Kacenga then presented the Fall 2025 Enrollment Forecast, noting a 4.87% increase in the undergraduate main campus, an 8.02% increase in the Graduate main campus and they are forecasting a 6.36% increase in the main campus total. For WPOne, they are forecasting a 2.35% undergraduate growth and a 6.65% growth for Graduate. The total overall enrollment growth forecast for Fall 2025 is 6.47% and 5.96% less dual enrollment.

Trustee Galandak thanked Dr. Kacenga and his team for their great work and let everyone know their efforts were noted.

Dr. Helldobler commented that while the fall numbers look great and growth is projected for next Fall, we are going to see one more year of contraction, a small contraction of about 3%. However, the following year, the University will begin to see more growth in our main campus. He stated that we are near capacity in terms of residence halls, and that is great news.

GOVERNMENT AND COMMUNITY AFFAIRS REPORT:

Vice President de Veyga informed us that his full report is included in the board packet. Dr. de Veyga updated us on the developments of legislative bill A4220, a bill regarding the transfer of academic credit and reverse credit at public institutions of higher education. He stated that disputes have not yet been addressed, and that the university shared this with the sponsor and the staff over the summer, as so have other institutions. Dr. de Veyga also briefly discussed another upcoming bill regarding capping tuition at 2% increases for institutions and requiring public institutions of higher education to post all syllabi. This concluded his report.

FINANCE, AUDIT, AND INSTITUTIONAL DEVELOPMENT COMMITTEE REPORT:

Chair of the Finance, Audit, and Institutional Development Committee, Kevin Lenahan, began his report by stating that The Finance, Audit, and Institutional Development Committee met on Thursday, September 5th, 2024. They met privately with the University Chief Information Officer and the Chief Financial Officer, followed by the committee meeting where they heard updates on the All-Funds Revenues and Expenses for fiscal year 2024 and estimates for fiscal year 2025 and reviewed bid waivers. He stated that they heard a presentation on capital projects that have been completed, those that are currently underway, and others that are planned in the upcoming years, as well as an Advancement report from Vice President Pamela Ferguson.

The FAID committee agreed to move the following three resolutions to the full board for approval.

It was moved by Ms. Cortez and then seconded by Mr. Galandak to adopt the following resolution:

RESOLUTION 9-24-2 FISCAL YEAR 2026 CAPITAL BUDGET REQUEST

The resolution was unanimously adopted.

It was moved by Ms. Cortez and then seconded by Ms. Niro to adopt the following resolution:

RESOLUTION 9-24-3, BID WAIVERS, CONSENT AGENDA

The resolution was unanimously adopted.

It was moved by Mr. Seeve and then seconded by Ms. Niro to adopt the following resolution:

RESOLUTION 9-24-8, NAMING OF THE READING CLINIC IN THE COLLEGE OF EDUCATION AT WILLIAM PATERSON UNIVERSITY.

The resolution was unanimously adopted.

Mr. Lenahan thanked all the cabinet members for their hard work and their presentations at the last meeting. This concluded his committee report.

EDUCATIONAL POLICY AND STUDENT DEVELOPMENT COMMITTEE REPORT

Trustee William Pesce began the report by stating that the committee also met on September 5th. They heard two presentations from registrar Susan Astarita, one about 4- and 6-year graduation rates and the other on the growth of certificates offered at the University.

The committee had two resolutions to move forward to the full Board for consideration.

It was moved by Mr. Galandak and then seconded by Ms. Cortez to adopt the following resolution:

RESOLUTION 9-24-4, ON THE INITIATION OF GRADUATE CERTIFICATES

The resolution was unanimously adopted.

It was moved by Mr. Seeve then seconded by Mr. Lenahan to adopt the following resolution:

RESOLUTION 9-24-5, CONFERRING OF DEGREES – SEPTEMBER 2024, AND

NOVEMBER 2024

The resolution was unanimously adopted.

This concluded Mr. Pesce's report.

PERSONNEL AND COMPENSATION COMMITTEE REPORT:

Trustee Bradley Neilley reported that the Personnel and Compensation Committee also met on Thursday, September 5th. He stated that they opened the meeting to all Board and Cabinet members included in personnel decisions. The committee has a resolution, which is a Consent Agenda concerning Various Personnel Matters. He stated that they examined the materials provided by Human Resources and the President's Office regarding personnel decisions made since the last Board of Trustees meeting. These included graduate assistantship appointments, fall 2024 master tutor budget, adjunct assignments, overload assignments, temporary appointments, leaves of absence, and various changes in employee status.

The committee had two resolutions to move forward to the full Board for consideration.

It was moved by Mr. Galandak and then seconded by Mr. Lenahan to adopt the following resolution:

RESOLUTION 9-24-6, VARIOUS PERSONNEL MATTERS (CONSENT AGENDA)

The resolution was unanimously adopted.

Mr. Neilley stated that the committee also reviewed the list of faculty who retired in good standing and recommended by President Helldobler for Emeritus status. NOMINATIONS AND GOVERNANCE COMMITTEE

The Committee met on Thursday, September 5th. Chief of Staff Mc Laughlin Vignier provided the committee with information regarding the election of officers which took place at this

meeting. The current officers, Michael Seeve, Chair, John Galandak, Vice Chair, and Robert Guarasci, Secretary have all expressed a desire to continue in their present positions and the committee submits these nominations to the full board. Nominations were open from the floor. All Trustees received an email with a link to the election ballot and voted.

**9-24-2 RESOLUTION, FISCAL YEAR 2026 NJ CAPITAL BUDGET
REQUEST**

RESOLVED: That the Board of Trustees of William Paterson University approves transmittal of the Fiscal Year 2026 seven-year Capital Budget Request to the Department of Treasury. The 2026 General Funds request is for \$84,102,000.

Acknowledges preparation and authorizes submission of a request for Capital Funding consistent with requirements of the State budget process. These listed projects are all included in the University's Three-Year Capital Project list and/or the Long-Term Campus Facilities Master Plans. This report is an annual requirement of the State yet we have not received any capital funds through the annual capital appropriation process since Fiscal Year since 2000.

9-24-3 RESOLUTION, BID WAIVERS (CONSENT AGENDA)

WHEREAS: The State College Contracts Law, N.J.S.A. 18A:64-52 et seq., requires that contracts be made and awarded by the state college/university only after public advertising for bids and bidding; therefore for non-prevailing wage contracts in excess of \$110,900; and

WHEREAS: The State College Contracts Law, N.J.S.A. 18A:64-56, permits in certain specified instances that contracts may be made, negotiated, or awarded by the state college/university by resolution of its Board of Trustees without public advertising for bids and bidding; and

WHEREAS: The Law requires that such waivers shall be approved by the Board of Trustees; and

WHEREAS: At its meeting of September 5, 2024, the Finance, Audit and Institutional Development Committee of the Board of Trustees reviewed proposed waivers as detailed in the list below; and

WHEREAS: The Finance, Audit and Institutional Development Committee reviewed the rationale and projected expenditure amount for each waiver, documentation citing each waiver's basis in the New Jersey State College Contracts Law, explanatory memos from the appropriate University staff members providing specific details about each waiver and discussed responses to questions posed by trustees to staff about specific waivers; and

WHEREAS: The Vice President for Finance and Administration and Chief Financial Officer has certified that there are sufficient budgeted funds available to pay the expenses authorized, and that the process employed in recommending these actions complies with all applicable statutes and regulations; and

WHEREAS: The Finance, Audit and Institutional Development Committee recommends that the Board of Trustees approve the following waivers, further specific details of which are enumerated in the attached documents, therefore, be it

RESOLVED: That the Board of Trustees of William Paterson University of New Jersey approves the waivers described in the attached documents.

- WHEREAS: The purchase of this service is exempted from public bidding pursuant to N.J.S.A. 18A:64-56 a. (15); and
- WHEREAS: The Vice President for Finance and Administration and Chief Financial Officer has certified that there are sufficient budgeted funds available to pay the expense authorized, and that the process employed in recommending this action complies with all applicable statutes and regulations; and
- WHEREAS: The Finance, Audit and Institutional Development Committee recommends that the Board of Trustees approves this expenditure herein; therefore, be it
- RESOLVED: By the Board of Trustees that the University President or his designee be authorized to increase the previously approved agreement with TNT Educational Services, Inc., of Paterson, NJ, for Fiscal Year 2025 thru 2027 from \$1,500,000 each year to \$5,000,000 each year for a total of \$15,000,000.
